

Information is provided on page 2 in the form of a Power Content Label, which is very much like a nutrition label and helps consumers make informed decisions.

Carbon neutral electric power comes from a variety of sources. Some power comes from renewable, carbon free resources such as solar, wind and small hydroelectric plants. Large hydroelectric sources are also carbon free, but are not considered eligible renewables by the state.

POWER SOURCES

In 2017, CPAU's hydroelectric generation was above long-term average levels as weather conditions were very wet following five extremely dry years. CPAU also had a few new solar projects that came online in late 2016. As a result, CPAU had an energy surplus and sold the excess generation on the market. 100% of CPAU's power remains carbon neutral. CPAU power sources include five solar photovoltaic (PV) projects in the Central Valley (Newman, Bakersfield, Kettleman City, and two in Lancaster), the High Winds and Shiloh wind projects, California landfill gas-fired projects in Watsonville, Half Moon Bay, Pittsburg, Gonzales, and Linden, the Calaveras hydroelectric project, the Western Area Power Administration (Western) contract and short-term contracts from the wholesale market that are matched with Renewable Energy Certificates (RECs). Western power comes from California Central Valley Project hydroelectric facilities. Percentages vary annually based on the available output from our contracted hydroelectric, solar, wind and landfill gas generators.
