2. Consideration of correction to Rental Protection Recommendation # 6, passed on February 9, 2023, regarding rental relocation assistance. - Eberle – Action

MOTION: Commissioner Kraus moved, seconded by Commissioner Savage, to approve the correction to the Rental Protection Recommendation number 6, passed on February 9, 2023, to read as follows: Council to expand the City-wide relocation assistance to multi-unit buildings with less than 10 units. Not including duplexes where one unit is owner occupied.

3. Discussion of a funding contingency plan proposed by the HSRAP Reviewers in the event that additional funds are approved by the City Council for the Human Services Resource Allocation Process (HSRAP) during the Fiscal Year 2024 budget process. - Kraus - Action

MOTION: Commissioner Kraus moved, seconded by Commissioner Savage, to affirm the recommendations made by the Reviewers for the Human Services Resource Allocation Process (HSRAP) contingency plan in the event that additional funds are approved by City Council for Fiscal Year 2024 with the following exceptions:

- 1. Increase the allocation to Ada's Café from \$6,000 to \$10,000 for both the \$100,000 and \$200,000 proposed contingency plans;

In order to accommodate the additional \$4,000 of recommended funding to Ada's Café, we suggest decreasing the allocations by \$1,000 for each of the organizations receiving the largest amounts: AbilityPath, La Comida, LifeMoves, and Ravenswood Family Health Network for both the \$100,000 and \$200,000 proposed contingency plans.
