#### 2. Approval of Minutes

#### 3. Review of Recent City Council/PAUSD Board Meetings

- IBRC Report: Separating out Cubberley for its own process.
- Regional Housing Mandate Committee: Consisted of Chair Greg Schmid, Council Members Burt, Holman, and Scharff. They discussed the opportunity to respond to social justice index and to network with similar communities and districts.

#### 6. Budget Update

District Chief Business Officer, Cathy Mak gave an update on the District's budget. For the current year, the State had midyear trigger cuts to school districts. The estimated impact to PAUSD was about \$400,000. Coupled with lower property tax growth this year, the District has a growing deficit. The District planned to make budget cuts of \$1.8 million in March to lower the structural deficit. For next year, the proposed State Budget included a tax initiative to keep school funding from further cuts. If the tax initiative were to fail, there would be more cuts to school districts. The Governor also proposed a new funding model for categorical programs. This new funding model would be detrimental to basic aid districts. On the local front, property tax growth for next year was trending better than the current year with the CPI adjustment back at the 2% cap. The District is looking at another round of budget cuts for next year with amount to be determined in the spring.

The City's budget projected deficit was below \$2 million, but revenue was improving.
