- History: 1 year ago InnVision merged with Shelter Network, for 7 years prior to the merger, InnVision had been the only local homeless services provider.
- Programs include: Food, Hotel de Zink Housing Program, Rental Assistance, Clothing Closet, Congregate Meal Program, and the Opportunity Center (OC) which was intended to be a one stop shop for homeless services and provides 88 units of permanent supportive housing.

Mila Zelkha, Strategic Relations Fellow for InnVision Shelter Network spoke about their housing and shelter programs. In addition to beds, they also assist with employment, overcoming addiction and mental health issues.

54 55 Is there emergency family housing? Hotel de Zink only serves individuals. There are no family shelters in Palo Alto or nearby; however they have utilized programs in San Mateo County.

• Are homeless individuals with criminal records allowed in shelter program? They only check to see if someone is a registered sex offender, otherwise they are not concerned with criminal records.

• Is there a maximum time limit to be able to live at OC. No time limit. OC is permanent housing. Residents can stay as long as they pay their rent, stay out of trouble, and continue to qualify within income guidelines.

• Are there medical and psychiatric services available for "drop in" services? Yes, twice a week, by appointment.

• Since the new ban on living in vehicles, has there been more demand for their services? Not yet, but they are welcome to use all drop in services at OC.

Case Management – They have (1) for families, (3) for "drop in", (1) for Hotel de Zink. 20 clients per case manager. Some clients do not want case management. It takes a long time to build trust and because it is a "drop in" center, you never know if someone will come back after you've started working with them.
