22 <u>Manager Specialist Rachael Tanner</u>: Good evening, I've got to get myself situated here, Good 23 evening members of the PTC and Human Relations Commission, Rachael Tanner, last time I was 24 probably before the PTC I was as the Assistant Director of Planning and Development Services. 25 But I've returned in a limited term role as a Manager Specialist with the Department working on 26 certain projects like the Safe Parking that is before you. And I want to thank Ms. Dao, she I think 27 is going to share the screen with the presentation. So, I have a brief staff presentation that

11 Manager Specialist Tanner: Just want to start out with a little bit of why we're having a joint 12 session, we don't often have joint hearings. Want to thank all of you for accommodating an 13 earlier start time, and for the HRC, a date that you don't normally come to City Hall, so thank 14 you for being here. Part of it was that we, is this working? Okay. Part of the idea is that we were 15 going to take this item to HRC for comment and then to the PTC for comment and 16 recommendation to Council, but instead of having it sequentially, the idea would be to have the 17 conversation together, so that the PTC and the HRC benefit from hearing and learning from 18 each other and sharing, and staff as well, and then if the PTC does make a motion tonight, it 19 really can encompass in the report to Council, can encompass the full conversation that is had. 20 So that is the reason for the joint session tonight. I'm going to start by going over some of the

1 program background and the services that are associated with the Safe Parking programs at 2 congregations in Palo Alto. Next slide. So, first just to remind us what Safe Parking is, the Safe 3 Parking programs provide parking lots where unhoused program participants who are dwelling 4 in their vehicles, can park, they can become connected to services and ultimately, they can find 5 secure and stable housing. And this program was developed due to the needs of unhoused Palo 6 Altans. And I should add that another feature of not just a parking space in a parking lot, that's 7 needed and hopefully has some more measure of safety than just parking somewhere on the 8 street. They'd also have access to restroom facilities, hand washing facilities and again 9 connection to services. Next slide. So, there are two types of programs that provide Safe 10 Parking overall in Palo Alto. One, the congregation based Safe Parking programs, so these are 11 religious institutions or churches, and then the 24-hour program, which is on publicly owned 12 lots. So, you can see here on Table 1, on the right, is showing the four congregations that have 13 Safe Parking programs in Palo Alto, and you can see when they first submitted the date for their 14 first permit and then when that permit was approved. So, we have Safe Parking programs in 15 operation going all the way back, the first one, in March of 2021, and then most recently in 16 June 2023, approved the most recent permit. And you can see here just a map of the four 17 congregations, as well as the 24-hour lot, the 24-hour lot is at 2000 Geng Road, so you can see 18 that kind of in the northern portion there near the Baylands. Next slide. This table shows the 19 participants and the placements associated with those participants so you can see again the congregations listed there, Highway, Unitarian Universalist, First Congregational, and then 20

1 you'll notice that Congregation is a name that doesn't have anything listed because they just 2 started, the data is still just a little too fresh to really report on their program. But this is going all the way back really the entirety of the program up to June of this year. And we did ask if 3 there are any significant updates from the June 30th date and there hasn't been... again these 4 5 programs are quite small and so there hasn't been a lot of updates. Just to remind the 6 parameters, these are programs that can house up to four vehicles, so they're maybe more 7 than one person sheltering in a vehicle so that's why you can have a number of unique clients, 8 but you also have the number household. So, you can understand kind of how the persons are 9 spread, or the individuals, couples, are they families. And so, you can see the unique number of clients that have been served, so a total of thirty-seven unique clients in twenty-five 10 11 households. And you can see positive placements. Again, you may recall from the staff report, 12 positive placement is that the person is leaving to a place that is designed for human habitation 13 whether that be an affordable housing unit, maybe they're going to live with friends or family, 14 or reconnecting with loved ones, perhaps they're going to another rapid rehousing or other 15 type of program, but it is permanent and secure and safe housing versus a non-positive placement would be maybe they're continuing to live in their vehicle but have left the program, 16 17 or have decided to live in a different type of location but not participate in the program 18 anymore. And so, you can see we've had seventeen placements overall of the... and it's of the 19 clients, so that's of the thirty-seven individual clients, seventeen of those clients have been ... 20 have gone on to a positive placement so it's about a 45% overall positive placement route. And

1 then I just want to note in the County in FY 23, this would be an attachment, I think it's 2 Attachment B that you all had, that had some of the diagrams around some of the data that in 3 the county overall, it's about 34% of the participants in FY 23 exited to housing and in FY 22 4 about 14% exited to housing. So, we've seen I think, relatively, again it's a very small group of 5 individuals and households, but we're seeing relatively good performance compared to the 6 county as a whole, which obviously is a much bigger universe that we'd be looking at. And then 7 just draw your attention to the last box, the point in time count, again, just to kind of get a 8 sense of the scale and scope, at the last point in time count 206 unsheltered folks, unhoused 9 folks were counted, 187 of them unsheltered, and of those 187, 181 were sleeping in vehicles. 10 And the vast majority of vehicles folks are sheltering in are RV's versus passenger vehicles. For 11 the most part these congregation based programs serve passenger vehicles, so a car, maybe a 12 regular SUV, but not the larger SUVs that you may sometimes see parked in parts of the city. 13 The 24-hour lot does, however, serve those who are living in RVs. Next slide. And this is again, 14 similar information but just also adding in the Geng Road site at the bottom, so that is the 24-15 hour lot, so again you can see kind of the placements, and this adds also showing... where the 16 households are affiliated with Palo Alto, so again we have a discussion around whether or not 17 we want to have preferences in this program. And so, you can see that we are tracking our folks 18 connected to Palo Alto in some way, is that somehow where they would see themselves as 19 maybe their last resident, maybe they have a job here, maybe they're in school here, and then 20 overall the number of nights provided and the occupancy rate at the congregation and the 24-

hour lot. So again, it's not necessarily even, and certainly the congregation has not had 1 2 operation the entire duration of this period of time, but again this gives you a sense of scale 3 and the scope. Obviously, the Geng Road site is 24-hours, it served 84 individuals in this time, 4 makes sense because it can serve up to twelve RVs, and each RV may have more individuals 5 living there, than in a vehicle. Next slide. Now on to the draft ordinance that is before you and 6 kind of what the proposed policy changes are. Next slide. So, I'm just going to voice over these, 7 but certainly we can go back to them if there's any of you that have questions on or want to 8 make further comments on, these are a few of the policy changes. The first is the permit 9 duration. The pilot program had kind of a ninety day kind of initial period and then an extension 10 and then you would need to come back and reapply to renew your permit. So, this is much 11 more like other conditional uses that we have in the city where once you apply for it and we say 12 that we believe you made the criteria, you have that permit, unless and until either it's revoked 13 due to not following the conditions of approval, there's a change of ownership. This permit is 14 not transferable; or, if the use is abandoned. So, if the church decided hey, we don't want to do 15 this anymore and then five years later maybe the congregation changed its mind, they would 16 need to come back in and get a new permit for that because too much time would have passed 17 between the operation. But, essentially we're saying the trial period showed that no news is 18 good news. During this entire pilot period we really haven't had any complaints and se we feel 19 pretty confident, we've vowed things in. We have had for each of the... each of the 20 congregations have gone through this process, we ended up hosting, as the city, a community

1 meeting, a neighborhood check in to let folks know what was going on, to ask questions, very 2 productive meetings, and so we're explicitly allowing the authority of the director to host that 3 meeting, instead of leaving it up to guess work. You know, could they, could they not and 4 typically we've been doing it so we might as well state that that's part of the plan typically that 5 we would be hosting that. And then again, you can see on the right side of the screen the 6 preferences. Again, this is a proposal to essentially say that these four categories would have 7 preference. If essentially, push comes to shove, if we start getting too much demand for the 8 spots we have, we would give preferences for the Palo Alto spots for persons who fall in this 9 category. Again, I want to note that the county and the program provider here in Palo Alto is 10 not super in favor of this preference in part because it's maybe not needed and we just haven't 11 had a situation where we've had more people than we had parking spots available, and also 12 they feel that they do already vet folks to try to put them in the placement that's going to be 13 best for them, so if somebody works in Palo Alto, they want to put them here in Palo Alto so 14 they can get to their job easily. If likewise, somebody might have connected with them here, 15 but maybe they're actually better placed in a different community that's closer to the things they normally do on a day to day basis. And so, they kind of feel like maybe it's a solution in 16 17 search of a problem, but I will say that when we do our community meetings, this topic often 18 does come up of like how do we know that we're going to be serving our folks in our 19 community and making sure that this problem is providing help to them. So, I can certainly see 20 both sides and bring it to you all for consideration. Next slide. So, in the proposed policy we also

1 are proposing to keep the appeal distance the same, it's about six hundred feet, so that means 2 that within that six hundred feet radius is where we mail notices to owners and occupants that 3 there's a proposal for Safe Parking program within your six hundred foot radius of that, and 4 that's also the folks who can file an appeal if they're concerned about the program. We're 5 continuing to propose that there's no fee charge for this, it does not thankfully take very much 6 staff time to approve and it's one way the City can help to not provide a ton of financial 7 resources but certainly not burden these programs any further. And then some minor 8 operational changes, really that again align with what the operator has been doing, and so 9 we've often put these into our conditions of approval, because it happens through the negotiation process, so again instead of having to go through that process, let's just put it there, 10 11 it's already black and white, these will be conditions of approval. Again, they're things that are 12 already happening and I think that probably the most ... seems the most important one's the 13 newest, is the reporting. Just asking for an annual report, and it lists the date of that we'd like 14 to have, so that again, we can continue to get a sense of how the program is operating and are 15 we meeting the needs of the community. Next slide. So that is the end of my presentation and I'm happy to be available for questions. Thank you. 16

<u>Commissioner Akin</u>: Thank you, Chair Summa. So, a couple of questions came up as I was
 reading the material, number one, what are the concerns about serving RVs and the
 congregation based sites?

6 Manager Specialist Tanner: So, I would say they probably come from two sides. From the 7 program operator side, they actually feel that because... and I again, I'm conveying to you what 8 they conveyed to me, so apologies now if I don't convey everything exactly accurately, but 9 essentially, because Move Mountainview operates the congregation base sites here but they also operate RV lots both here and in Mountainview and in other communities and so in their 10 11 experience, I think just the nature of the RVs, they're better suited for places where they don't 12 have to move every day, and so I think participation in a congregation based lot just tends not 13 to be a very good fit, for those households, and so they really try to put them in to a medium 14 more suitable lot. Also, just due to the sizing of the RVs itself, the way that they have to space 15 the RVs to have distance between them, it can just create more challenges in the congregation 16 lots when you're limited in the number of vehicles you can have, to four, so I think both from a 17 household service perspective and from like a dimensional perspective, it becomes harder to 18 serve them in the RVs. I think from neighbors who again, are expressing concerns before the 19 programs are operating, and not necessarily after, I think there's a concern around maybe 20 unsightliness of RVs, or kind of would there be more problems that could be associated with

folks who are living in RVs and those who are living in vehicles, I think that's a little bit you know, maybe just concern that may not have born out, but I know again for the program operators perspective they prefer... and I would say... if another operator came in and worked with the church, and wanted to serve RVs, they would be allowed to under the ordinance, but the current operator just chooses not to and that's totally fine. But it's not the ordinance that's preventing them from doing it.

8 <u>Commissioner Akin</u>: Very good. Thank you. That segways into the next question I wanted to ask. 9 You're probably going to get several questions about the number of spaces on each site, so one 10 that I had was, is there a tendency for multiple households to shelter as a group? Because if 11 that happens, then either the site might not be large enough or given the low utilization 12 numbers, it may be that their avoiding them because there's not enough space to handle 13 everyone.

<u>Manager Specialist Tanner</u>: That's a good question, I hadn't asked that question specifically of the service providers, like if that's a common occurrence so... but they didn't volunteer it, doesn't mean that it's not, by I just couldn't say definitively one way or another if that's a common occurrence in terms of households being in multiple vehicles, wanting to be together and not being able to find sufficient space.

1	Vice Chair Chang: Okay. And then, what's the Capacity of the Geng Road location, the report
2	says twelve RVs, but does it also have additional spaces for regular vehicles?
3	
4	Manager Specialist Tanner: Well, certainly it wouldn't have so I would say if lets say they had,
5	obviously not RVs bigger than a car, I don't know that they would double up a space there, and
6	kind of have two cars parked in an RV space, and I think they do try to prioritize RVs there; I
7	would say twelve overall, but certainly if they reconfigured it, vehicles could be more.
8	
9	Vice Chair Chang: Thank you. So, I'm sorry, I'm trying to read my list of questions here. Oh,
10	following up on Commissioner Akin's question about congregation sites not being ideal for
11	serving RVs, is it also because of hook ups that are needed, or is that an issue at all?
12	
13	
	Manager Specialist Tanner: So, the RVs, even at Geng Road, there's not like really sites for them

I mean on the positive side, we do hear anecdotally that some folks are there just 10 for a few days. You know, by the time they get in the program, they're able to get resourced 11 into housing. Sometimes it just depends, there are example a lot of resources to get households 12 with children, into housing very quickly, and the county does a really good job of finding households with kids places to stay that are permanent and were stable. 13

<u>Vice Chair Chang</u>: So, when you were talking to the administrator, did they ever cite any examples where people had to be turned away, where they had reached capacity? Because, overall, the program is... we have more room, right... than is being used. But I'm wondering, is there a seasonality to it or do they ever ... because even with the RVs, where there's only twelve RV spaces, the vast majority of people who are being housed in vehicles are in RVs, but there's not ... but even the Geng Road location is only at 64%.

17	variety of personal needs or decisions, so I wouldn't be able to hazard a guess on why one is

6 Mr. Love: I would have to review our data on that a little bit, I think that's really a good 7 question, I have to admit I hadn't looked at it that way comparatively. But my hunch is that we 8 get some younger folks that have taken to living in their car and some very old folks who have 9 taken to living in their car, but the placement tends to be easier for a single person to be kind of 10 slotted into either some kind of permanent support of housing or rapid rehousing, or even find 11 something affordable for them. They may have work, for example, that is compared to our RV 12 families that may not be working. And there's some challenges there. And that I don't know. 13 There's certainly some interest there, in getting out of their RVs, it appears, but I really have to 14 check that and get back to you why that appears to be happening. I think there is value in 15 having the smaller lots, for the reason as has been pointed out, should the parking start to be 16 harder to acquire on the street, in the future, that may impact the cars as much as the RVs and 17 so having spots that, even though there are some open, we are almost at... we're at 47% 18 tonight I think, on the church lots I counted. But, to have places available for people quickly has 19 been helpful. We can often take the car dweller in the day we get the application, interview them, and get them situated on a lot pretty quickly, which is helpful. 20

16	away and get them inside, it's the concern that we wouldn't be able to get emergency vehicles
17	in there for their safety, but not, they're absolutely encouraged to play on the lot.

2	Commissioner Causey (HRC): Hi, thank you. As somebody who used to work with ARC faith
3	based organizations, and also with community members that are very close to considering
4	these programs, this is just really fantastic work to see. My first question is, I was wondering
5	how did they reach the number of maximum vehicles being four?
6	
7	Manager Specialist Tanner: That's a good question. When we created the program and the
8	Council asked us to look into it, we researched other neighboring programs in other cities that
9	were similar, Mountainview being one of the closest and kind of having the more long standing
10	programs, and kind of mimic some of the numbers that other cities had for their projects, and
11	so four was a number, I would have to say I can't remember exactly all the cities, but four was
12	the number, I think in Mountainview and I think they have at some point allowed eight vehicles,
13	I want to say, but maybe it had been adjusted to four. And so that's kind of where the City
14	settled.
15	
16	Commissioner Causey (HRC): Got it got it. Are there any further, I was also looking at other
17	cities programs, are there any further regulations around RV safety, I just know in other cities
18	there's been concerns about them being very flammable.

1 Manager Specialist Tanner: Yes, so, in regard to the RV lot, and I'm would say I'm not sure if this 2 is in the ordinance for RVs or in the way that the lease has been written with Move 3 Mountainview for the specific Geng Road site, part of... even for the congregation based sites, 4 part of what you have to have is a site plan, that shows where the vehicles are going to be 5 parked, in a congregation based program the parking lots are usually ample enough that there's 6 plenty of room, it's not really a huge issue in terms of a fire safety, it's more about spacing 7 between the vehicles to provide some privacy, as well as kind of put them in the best situation 8 for even privacy from residences or other nearby uses. At the Geng Road site, because the site 9 is quite... it's got a long rectangular site, which can be hard when you're maneuvering RVs in 10 and out of, and so there was a lot of work done to really space out and mark out where could 11 those twelve vehicles be, and as well as having fire safety access. So, that site plan had to be 12 reviewed by the Fire Department and that's where kind of the twelve spaces for the vehicles.

13

14 <u>Commissioner Causey (HRC)</u>: Got it, got it. And final question, you were talking about having 15 the preferences in this policy for people with ties to Palo Alto et cetera, and also that there are 16 currently openings in the program, and walking that line of the program manager saying that 17 there is already a ... they try to match people with the best sites possible, is there any concern 18 that implementing these preferences could create like more vacancies?

1 Manager Specialist Tanner: Well, I think that would be... so I think what we would not want to 2 do I think collectively, would be to do things that would prevent what he just described 3 happening where someone can walk in and say hey I'm ready to participate in the program and 4 that very moment they're getting placed right, so that there's that immediate, we're able to 5 serve you; not... so come back later, right, which is not what we want to tell somebody who is in 6 a vulnerable situation. At the same... so I think the scenario where the preferences become 7 either necessary, or a challenge is when we start having scarcity at sites. When there's not 8 enough available slots to easily put someone in a place, and so we might have to say well, you 9 know, we can't place you in Palo Alto because X, Y, or Z, and so we'll have to wait until there's a 10 spot available to you. I think certainly the preferences would not, I think, suggest that someone 11 be removed from a site who's already been placed, but more part of the screening of like you 12 know, to place them in a Palo Alto site if there were a wait list that people with connections at 13 Palo Alto might go up higher on that wait list, for the Palo Alto sites. I don't know if that 14 answers your question.

So, what we have been doing in the current ordinance that 4 is on the books right now, essentially is that we receive an application, we review the 5 application once the department, in this case it's the authority of the Director says yes, this 6 application meets all the criteria, we are going to issue a permit for them to operate a Safe 7 Parking program. That is when we send a mailed notice within six hundred feet of the site, and 8 saying, there is a pending application that is going to be approved in fourteen days, unless you 9 appeal it then it will happen. So, that kind of creates an environment where if a neighbor is just 10 not sure and doesn't know what it is and is concerned, then it feels like their only avenue is to 11 appeal it, right, and to say I've got to just appeal the whole thing because that's the only thing I 12 can do. And so what happened in practice is we would essentially say like okay, we're extending 13 the appeal deadline in order to hold a meeting, hold the meeting, talk to folks, have dialogue, 14 get to point usually where the congregation and the neighbors reach some type of agreement 15 or understanding or a trust, because the congregations want to have good relationships with 16 their neighbors, and then we pick up and say now the appeal deadline is there, no one appeals 17 it because we've gotten to a good place, and the permit is issued. So what different now is that 18 the Director can say, we're going to hold a community meeting, which I would imagine in most 19 cases, unless it's a congregation that has no neighbors, we would do, hold the community 20 meeting, and then after that issue the notice. The first notice would say you're invited to a

2	second notice would say the meeting happened, based on the input, Director is going to issue
3	the permit, you have fourteen days to appeal. So, there is still an appeal process if someone is
4	not satisfied, or concerned, but it happens in a more, hopefully collaborative environment
5	versus kind of the only thing you can do is appeal, or feel like the only thing you can do is
6	appeal the permit itself.

Manager Specialist Tanner: The one congregation that I can think of I think one, the pandemic, let's say that happened after this ordinance was adopted, so they ended up using a lot of their rear yard space for meeting space, their parking lot for outdoor meetings and for holding their church services. And them some other facility enhancements and since then, I just don't know what's happened internally to the church, but they haven't approached us yet. So, that's the one example I can state. So I'd say I guess internal to the congregation would be my answer.

10

11 <u>Chair Smith (HRC)</u>: Because I noticed on Page 15, of the packet, two of the points was 12 opposition from neighbors and changing the neighborhood notification process. From what I've 13 heard from some churches, it's become very daunting for the neighborhood process because 14 you only have one or two voices that can coalesce against them. How do we balance the church 15 trying to do good for our people in our community versus one really loud person in the appeals 16 process, trying to push the issue?

17

18 <u>Manager Specialist Tanner</u>: Yeah, that is like a question of democracy I think, out do we weigh 19 the needs of the few and those of the many and where do things fall. I will say this proposed 20 ordinance continues the ability for a neighbor, or resident, or property owner within 600 feet,

1 so it isn't anywhere, it's within that six hundred feet radius to file an appeal. So, I think that was 2 one attempt to try to say that a person filing an appeal, even if it's just one person, has a close 3 in stake to what's happening... right... their proximate to the issue and I would say to your 4 earlier point on the daunting-ness, particularly the first congregation that went through it, you 5 know it was probably not very pleasant. It was a lot of work and it was a lot of conversations 6 that they may not had anticipated, and a lot of bridge building and smoothing with their 7 neighbors. And so, I don't want to say it's not a challenge, I'm not sure... we could change the 8 appeal process, the PTC could opine on a different process, however I'm not sure... what we can 9 do, our attempt to kind of institute the neighborhood meeting, more regularly, is like we're going to come to you and tell you what's happening and share with you, is one, I think less 10 11 effective and somewhat hard to administer would be requiring the church to hold its own 12 meeting but I think often until the city sends the official notice, sometimes folks aren't really 13 listening. And then when that happens it's like oh! This is really happening, now I would like to 14 get more involved.

1 Mr. Love: Yes, hi. I had that right in front of me because I thought that might come up. Who's 2 on each lot and how many. Hang on a second. The short answer is that Etz Chayim has had 3 clients on the lot, and to the eye of the beholder they tend to be invisible because they don't 4 necessarily show up... they never seem to show up exactly at seven, or whenever that particular 5 congregation's lot is open. And they tend to leave as soon as they get up to go off and do their 6 business, so, we've always experienced that there's not very much interchange between the car 7 vehicle dwellers and the host congregations. That's not unusual. It has been a slower start for 8 sure in Palo Alto to begin to fill... fill the lots, but we have folks on every lot tonight, and on the 9 congregational lots we have seven across the system so there's three with two clients and one 10 with one client. But they are generally allusive. It's work for us to make the connection which 11 usually happens in the daytime by phone and text, just to schedule their visits with their case 12 workers. Because they're just, by definition, using that property lot less than an RV dwellers. It's 13 sort of the opportunity to run into to each other is less.

14

<u>Commissioner Kraus (HRC)</u>: And that's regarding the most recent lot that got added I see. You
 know, I know there are three synagogues in Palo Alto, I don't know how many churches there
 are, or mosques; that might be some really useful data, long term.

want to elaborate a little bit on Vice Chair Chang's question and redirect it a little bit to Mr.
Love. How is the four vehicle limit actually enforced and how often to we actually hit four
vehicle, the four vehicle capacity on any given site, like how many nights per year?

7

8 Mr. Love: That's a really good question. The way we regulate the number of vehicles to four is 9 that we do not place more than four. So, there's no scenario in which a client can drive in. 10 They're absolutely required to file an application with us and go through an interview and 11 screening process so it's not a ... well somebody told me... it's not like you're pulling into a camp 12 site at Yosemite and telling the ranger in the morning. They have to be pre-registered, and so 13 since the custom and the rule is four, we simply don't enroll more than four. That's ... we have 14 been full, only very occasionally at the congregational lots, but it's easy to regulate it. I think it 15 is a question of having too many vehicles. If more than four strikes me as being tricky because it 16 can start to take on... be a bigger task for the congregation to host more vehicles. I know it's 17 tempting because they're smaller units and there's often a lot of parking spaces that aren't 18 being used, but four seems like a good way... and maybe in a year or so, we know how to do 19 this well enough that congregations and the communities and the municipalities might make a 20 change in that, but four seems likes a comfortable number. It allows the community, the

congregations to participate and help and it also encourages their neighborhoods ... that hey,

site visits each night and morning, so that's also part of the making sure that the unhoused
don't decide... oh hey, let me just go park there, so, there's that kind of, on the enforcement

Just to drill down a little more, so there's been 12 a few nights where we have been at capacity across the system at the congregations, it 13 sounded like. So, in those cases have we actually needed to turn people away? Or, even... or, 14 just in general have we ever needed to turn people away from the congregation sites?

4 Manager Specialist Tanner: Well, I can offer some and then would ask Mr. Love to offer any 5 additional comments. I think certainly there is a requirement to leave in the morning, and then 6 return at night, so, if someone doesn't prefer to have to move that frequently, that would 7 probably be just a very practical barrier for someone to say well, I can do the same thing 8 without you know, the benefits that you're offering. Which would namely be a safe and secure 9 and relatively clean restroom and you know, the monitoring and the connection to services. So 10 if someone didn't feel those were benefits to kind of in the trade off to needing to move 11 routinely, which they still would need to do in their vehicle, but maybe not as frequently. I 12 mean maybe not at those specific times, that could be one programmatic limitation. Certainly 13 we know that the congregational lots have vehicle type limitation, in accordance with program 14 operator's kind of preferences, but I don't know Mr. Love, if there's any additional barriers that 15 kind of prevent folks from wanting to just even connect to a service at all, whether it's twentyfour hours or overnight, that they'd rather just be on their own versus working with you all. 16

18 <u>Mr. Love</u>: I would say that's true. There is a... you know, vehicle dwellers are as unique as you 19 and I are in our neighborhoods, all the rest of our neighbors; and there is a slice of that 20 community, it's not a great big slice, but there is a slice in that community ... a segment of that

1 community, that really doesn't... you know, is sort of out there to be an independent as they 2 can be. And they really don't want to be in the... under the care of a program that requires 3 them to meet with a case worker, et cetera, et cetera. So, it's not as attractive to somebody 4 who's gotten used to being utterly independent and alone, which is kind of a shame, because 5 often those folks suffer the most in terms of state of mind from being isolated. But there... 6 we've tried to think, and haven't come up with anything, I'll admit, ways to make it so that it 7 seems... so that there's more value to somebody to be in the program, other than to just get a 8 safe place to park, because basically I can find that behind Safeway. And, if I don't want to work 9 with a case worker, that kind of seals the deal. I wouldn't want to be in the program. I know 10 Palo Alto is beginning a really good outreach program with the hiring of some community 11 outreach workers. We hope that just as we get the word around, we'll start to see more people 12 who will check us out. But what's keeping them away seems to be primarily, in the 13 congregational lots particularly, they just are not that eager to go in the direction of housing. 14 That's rarer in the RVs.

15

16 <u>Commissioner Lu</u>: Got it. So, the main limitation in the program is almost that it is a program at 17 all. One last question, on the operator side, are we concerned about any of the operational 18 challenges that we're proposing to encode here?

I noted certainly that the preference program was not well supported by Move Mountainview, I don't believe any of them are minor operational changes had any challenges, those are on slide 10 if ya'll have the slides but certainly Michael, you can speak to any of the challenges that you may have noted.

5

6 Mr. Love: The preferences, I don't want it to appear that we're not you know, supportive of 7 that, we're absolutely can support that. We explored that as whether that would be good or 8 bad for the Palo Alto wanted that... the program to unfold in Palo Alto, because we had noticed 9 some limitations that placed on the Mountainview program, and we kind of explore that together but at this time, the way that those are painted in the ... the proposed regulation, I 10 11 don't see that as being a constraint for us. This statistically, even when we're early on in our 12 work, we're just... in taking people in and talking with them and learning about them, we're 13 finding that we're talking to local people, eighty percent of the time. So, as I think you brought 14 up earlier, somebody who has work in, doctor, you know, neighborhood in Gilroy is not very 15 interested in commuting from Palo Alto down to you know, Gilroy, just for a place to park. So, the preferences are one thing I would want to encourage us to just... that's workable, it's not 16 17 going to be a disincentive for us.

And I think 6 you've highlighted that so I don't need to go into more detail. I do want to ask some tough 7 questions here tonight, we do have a difficult political environment that we're also navigating 8 and so I want to just talk about... we have a section in here about vetting the client, the 9 application, how background checks are dealt with, and the question that comes to mind is ... is 10 it possible or how does it work if somebody is ... let's call it poorly behaved on one site, can they 11 move then to another site or do they get some kind of red flag on their account, and can you 12 speak to that Ms. Tanner, we'll start with you and then Mr. Love if needed.

13

<u>Manager Specialist Tanner</u>: Yeah, so, I'll say maybe just to start over all, that there are... just maybe have to landscape a little bit because I think years go beyond, just like Palo Alto, but to the region, right. And so there is a lot of coordination at the county level that the county is kind of the center and there is a unified system that all the providers, whether they're in Safe Parking, or another type of shelter program participate in, so, ideally for both the participants and all the program providers, there's like one John Smith in there and if they go to this place for that, or here for this, everyone knows it's the same person receiving different services. So

1 there's a high level coordination at least kind of from that level. What I would ask Mr. Love.... I 2 know that he's spoken to this several times in community meetings, around their no tolerance 3 in Move Mountainview for certain behaviors and so people would be asked to leave the site, 4 maybe you can speak more directly Michael, if someone you know, engages in some behavior 5 that's not great at your site, would they be able to go to another program operator who would 6 maybe not be aware, or if you're able to flag that in the coordinated system that this person 7 may need a different type of place to have a program that maybe gives more guidance or 8 boundaries that help them to still get housing, but maybe not a parking lot site. Mr. Love, could 9 you speak to that? If you have any of those...

10

11 Mr. Love: Sure, yes if we have some one who's egregious in their violations, we can put a note 12 on the system, a systemwide note that says this is why this person is no longer going to be served by Move Mountainview. You know, either there's a... whatever the incident is... and so 13 14 everyone is advised that at the very least, they want to have an extra deep and long 15 conversation with this client if they show up for services. Internally, we don't move someone... disgualify some one from one lot and then put them on another lot. If they're disgualified from 16 17 the program, that's system wide for us. They can't go to another lot, say from a Palo Alto lot 18 and come over to a Mountainview lot. Now if it's a subtler kind of situation where it's not a high 19 level egregious violation it may be just a matter of chemistry, we might move somebody around 20 before it comes to that, if we see that there's some bad chemistry. We try to not street people,

1 we want to keep them if we can, but there are absolutely things that they can do on our lots 2 that they'll be told to leave immediately. There's other things that are less volatile, where we 3 may give them three warnings and then say you're not able to come to terms with this for 4 following the rules, but the fact is, that most people who are discharged, are people who are 5 very nice people, who haven't been rowdy or anything, but they really made it clear that they 6 just don't want housing, and they'd really like to park in our lot forever. And they county simply 7 won't allow us to do that. So most of the discharges I do are because people don't want to 8 engage in the program.

9

Commissioner Templeton: Thank you both. Yeah, I'm thinking of a pretty dangerous edge case 10 11 right now, and I recognize that's not something you've normally encountered and hopefully we 12 don't encounter that, but I do want to make sure that we, as a body of the City, are thinking 13 about that and working with our partners on it. Specifically, we are encouraging our faith 14 institutions to participate, but we're having hate crimes against our certain faith communities, 15 right, and also, we have identity, we want people to be safe in our programs, and I'm not sure if 16 three strikes for hate violations would be acceptable, I want to make sure that we can say... 17 that we don't pass somebody from one synagogue to another synagogue if they are hateful. 18 Right. Like I want to think about that and make sure that our partners are thinking about that. 19 So, I appreciate your explanation and I would love to see us add a little bit more safety in that 20 area. Thank you.

5 can approve whoever asks, I noticed the point of time count has gone down, but I'm suspecting
6 it will go back up this year given that some of the COVID rental protections have gone down and
7 the homeless population is spiking, has gone up dramatically in shelters in the first six months
8 of 2023. What is the maximum number of places do you think that the City A) Needs or B) Can
9 handle?

10

11 Manager Specialist Tanner: Yeah, so I was just doing the math, so if we're doing point in time 12 count math, there are ... you know if 181 folks are sleeping in vehicles and 68% are RVs, then 13 that means 58 people are sleeping in cars, or not in RV vehicles. So, that would be... assuming 14 that they are each in their own vehicle, that would be 58 parking spots. Which we're at sixteen 15 right now. Now granted, each of those folks is probably not individual, they are some individuals that are in combined households but you know, we'd need a significant number 16 17 more parking spots than we are, if every person living in a vehicle said yes, I would like to 18 participate, you know, in this program.

So, Packet page 12, the second paragraph, says of the 206 11 people in this year's Palo Alto counts, 181 were sleeping in vehicles, which is nearly 90%. But if 12 you go to the next paragraph, it describes 2022, with... of the 276 unhoused Palo Alto 13 households, 29% identified their vehicles as the most frequent place they've slept. So, that's a 14 big delta, and I was wondering if perhaps the 181... I wanted to find out if that's a correct 15 number or maybe it should have been 81, because that's roughly a third, closer to a 1/3 of the 206. 16

 point in time count, and the other is numbers reported through the county's VI-SPDAT system, I

20 believe, I'm not sure if that's how they pronounce it... what did you say?

<u>Manager Specialist Tanner</u>: Great, much better than my pronunciation of it. The VI-SPDAT system just rolls off the tongue doesn't it, so those are two different measures of counting ... the point in time count is literally going around and surveying individuals in the real time as they are waking or sleeping. Whereas the VI-SPDAT is going to be... I would imagine where people were interacting with the county, and so it's maybe a different measure of the data. We've got to take it in. So, we've provided both, their numbers are different, but to try give a sense of magnitude of the challenge.

11

12 Commissioner Hechtman: Okay, and I do think that's important to tie into the last question 13 because if it's 29% are regularly sleeping in vehicles that reduces the demand from 58 to some 14 smaller number. Okay. Next question, let's see this is actually in the ordinance. One of the new 15 suggested additions to our ordinance as it becomes permanent, is on Packet Page 27, no 16 temporary structures, no temporary structures or amenities such as clothes lines shall be 17 allowed to be erected in relation to the Safe Parking program. So my question is, is a folding 18 chair or a play pen, are those amenities? Are we.. because I, you know, if they're not intended 19 to be, I think we need to clarify that language, and I understand at Geng, the children are

encouraged to play, and I would think that there might be a playpen or something that you
would call an amenity, so is it the intention that you can't have things like folding chairs?

<u>Manager Specialist Tanner</u>: I would say it is not the intention, to not have, you know, chairs or
other... I think going in concert with the next one, personal property, not that it shall never be
outside of the vehicle, but that it wouldn't just kind of be there in perpetuity until the person
leaves the program, but they'd bring in and out kind of on a daily basis.

9 Commissioner Hechtman: Okay, that's helpful, so I would encourage a little bit of looking at 10 that word amenities, just so, again, because part of the issue we will have long term, is not only 11 churches looking at this language, but also neighbors. And I don't want a fight in the future 12 where in a congregational parking lot, somebody has put their chairs out and neighbors say 13 hey... that's an amenity. Right, so I think we should clarify that. Alright, couple of comments, 14 first of all, I am a member of congregation Etz Chayim, as is Commissioner Reckdahl who's not 15 here tonight, and earlier this week I did talk to our Executive Director to get feedback on the 16 program. Since the permit was received in June the program has operated very well, there have 17 been zero incidents, problems of any sort. It is undersubscribed. Typically there is a single car 18 that will use it on a given night, and the most there have ever been is two. I did also confirm 19 that restrooms are at least twenty five feet from the street frontage because that location, 20 along Alma it's closer to the street. Some of these, as I understand, some of the congregations

1 have them maybe tucked back, but I do think that we need to think about that twenty five feet, 2 while generally it make sense, but we could have a situation where that would be a bar to some 3 congregation that wants to institute the program. And so I think the Director should have some 4 flexibility. On the preference list, my thought is, we should not include it, at least until we 5 become over-subscribed and then, only as to the City lot. And it doesn't need to be in the 6 ordinance for the City to do that. I do think it's important for these congregations, that they be 7 able to pursue their mission as they see fit, and I don't want that kind of requirement to be a 8 bar to some congregation that might otherwise be willing to start this program. I want them to 9 have that flexibility and honestly, we all... I think know that this is not a Palo Alto problem, this is a national problem, which regional impacts. You know, where our city limits end at the next 10 11 city's beginning, I think that it's important to place as many of these unhoused people in a safe 12 environment, every night as we can, in every city. So, I'd not be supportive of that. One item... 13 the last item I'll bring up and nobody has mentioned it so far, but it's in the staff report, this 14 concept of density of permits. And that is, you know, just a notion of how close to each other 15 can congregations who have this service be. I do ... I think this is an opportunity where we can 16 be sensitive to neighborhood concerns, and I think that someone who is within 600 feet of one 17 of these sites, can express their concern. I think it may be too much to have that same person 18 within 600 feet of two sites. That might feel like an overconcentration to them, and I think that 19 would be a reasonable way to feel. So, I would think that we might want to separate them by 20 1200 feet. So that no person was... so that no resident was ever in that situation where they felt

concerns coming from two directions within 600 feet. Those are my questions and comments,
 thank you.

4 Chair Summa: Okay, I'm not seeing any lights so I will take a... make a few comments. Lots of 5 really great questions asked, so I don't have a lot of questions left, I will agree with 6 Commissioner Hechtman that I don't think the preferences are necessary at this time. And I 7 would like to give as much leeway to faith institutions that would like to be a part of this 8 program, to craft a program for that... that works for their mission. And I also think that some 9 faith institutions might feel they can handle more than four vehicles. And some faith 10 institutions have very small lots, and some have very big lots. So, I think there might be a better 11 way... there might be a way to include that notion into the ordinance. Yup, to allow more than 12 four vehicles. I would like to see that. And I appreciate that Mr. Love mentioned that it might 13 become overwhelming for an institution to have more than four, but if they felt like they could 14 support more than four, and maybe there's a way to do it with the... I mean I think there's a lot 15 of discretionary power that we have to where we put these cars, so I don't think it should become a problem. And who knows, I'm not quite sure how I feel about the density, I don't 16 17 think it should be a really big problem, because we're so carefully siting these on each parking 18 lot situation that I don't see how anyone would feel overwhelmed, and it also occurred to me, 19 this whole thing, I'm glad that we're doing it this way, within a permitting process, but I was 20 always surprised that a church said we can let someone use our parking lot at night if we want

1 to. So I really appreciate that we have a more ... a regulated permitted process to go through. I 2 think about the appeal process, I wanted it clarified that it's just our normal standard appeal 3 process, as written in the code... Okay. 4 5 Manager Specialist Tanner: Actually, it does get appealed to the City Council, that directly to 6 City Council for decision. So, I don't think that's for all permits, but there are some permits 7 where the appeal is directly from the neighbor to the Council. 8 9 Chair Summa: Okay, so this one goes directly to the Council then. Okay. Alright, thank you for clarifying that. So, I think this is a great improvement to offer this citywide, so I just wanted to 10 11 thank you for doing that. I don't see any lights, do I have any other comments from my 12 colleagues or my new colleagues? 13 14 Chair Smith (HRC): Just one comment on density, I know the place that density will be a 15 challenge is Middlefield. Because I know there was one church that was offering it within six 16 hundred feet of us, and people were like... are you going to offer it, because we would be... 17 we're within 600 feet of probably four churches. So, I think even if there was a carve out for 18 Middlefield, and saying along that church road corridor, not having like, things contiguous 19 within 1200... I think that area specifically we'd have to address. But, I don't think it's anywhere 20 else in Palo Alto, if I can't remember.

3	discussion just for clarification, the appeal fee is \$700 dollars, not \$600 dollars. It's gone up
4	since I was last here. And the VI-SPDAT system is one that is indicating folks who have wanted
5	to engage and are looking for, or seeking, or participating in services, and so that's probably
6	around like twenty-nine-ish people or thirty folks. So, we think about 58 is the total number
7	who are sleeping in vehicles and of those maybe thirty or so, who are like I would like to not
8	be doing this and work with the county or work with others to get out of that situation, so,
9	we're about halfway there. If we think about it being roughly thirty, in terms of the number of
10	parking spots that we have available.

12	Chair Summa: Other comments?

hurting, but the fire and Mike's Diner almost closing, and trying to revitalize the businesses there, and maybe revitalize the whole corridor, so I do think about equity between north Palo Alto and south Palo Alto, and there's I guess First Congo is north Palo Alto, and it's the only one that is part of the program, I... so... but at the same time, I was thinking I don't know how much parking the other churches have, do you... I mean I don't know how many churches there are on that side, and I know the ones in downtown don't really have a lot of parking. So... is that just the way it is, basically?

8

9 Manager Specialist Tanner: Yeah, I think you make some good points, just in terms of where 10 churches are located, is not evenly distributed, and so... and even to your point, the kind of age 11 in which the church was constructed and the kind of parking associated where you can just kind 12 of... the spaciousness, is not evenly distributed either. So, that could lead to saying yea we do 13 want to have some type of density limit, just to make sure that... because south Palo Alto 14 happens to be where most of the churches with larger parking lots is, does that mean that's 15 where all of the Safe Parking lots need to be. And so, if we're kind of saying, happy medium, maybe it is 1200 or 600, or 600 feet just to give some breathing room, and not make that part 16 17 of town feel like they have to have all of the Safe Parking there. Even though that's where most 18 of... many churches are.

4	partnering with agencies that we already have, that have ties with the RV community. So, I
5	wanted to let you know that.

7	Chair Summa: Thank you for that. May I ask you a question. Anecdotally, I notice a huge
8	diminishment of the RVs parked on El Camino in front of Stanford, do we have any idea why?
9	Did people just leave during COVID, I mean this may be some of it, or

12	my colleagues is maybe Melissa

6	McDonough, Assistant to the City Manager.

8	Chair Summa: Hi, yes, thank you for joining us. Yeah, I was just curious, anecdotally, because I
9	count them as a habit, when I drive by and there were thirteen today. And at one point there
10	were over forty, so I'm sure wondering, if anybody knows what, if they found a better place or
11	if they've moved out.

13	Ms. Melissa McDonough: I can only give you an anecdotal answer, in return to your anecdotal
14	question. During my conversations with our police officers and some of our service providers,
15	recently there's been a lot more movement of RVs off of El Camino because of Stanford football
16	games. So you may just be encountering the displacement of those vehicles, is what I would
17	expect.

So, it looks like there's maybe a total of less than sixty 6 right now, if assuming that the numbers don't change, as Chair Smith had mentioned that they 7 are already changing, but maybe sixty cars, or non RVs, and then about 120-ish RVs, and so it 8 actually seems like it's the RVs parking that would be a real challenge. Do we know where they 9 are going right now? This is kind of a piggy back on Chair Summa's question, as well as given 10 that we only have twelve spaces that are suitable for RVs what's the solution there? And it also 11 sounds like the RV, that housing the folks in RVs is a stickier problem because they might need a 12 larger space because there's more people in the household.

<u>Manager Specialist Tanner</u>: Yeah, certainly I think I'd refer to Ms. McDonough, where folks are going, or Mr. Love in terms of where do folks go when they're not parked where they may have been parked. I'm sure there's a number of places. I think certainly the numbers would suggest that if we had more capacity for more RVs to be parked, there could be more participation by those living in RVs in the program. Certainly we have a pretty... the amount of space we have relative to the number of vehicles is pretty lopsided, right, twelve spaces and 181 people and 68% of that are living in RVs, so I think it's like 123 if we use the point in time count number. So,

1 you know, not really a one to one space. The options would be to try to expand the public 2 program, which you know, the city identifying more of its resources available for RVs, that 3 could be one option. Another option, which could be considered is to allow other types of lots 4 that are not congregations to also host safe parking programs, and so that might be a shopping 5 center, it could be some part of the research park, or Stanford, or other types of institutions 6 that may for a variety of reasons, want to do something like that. I believe this is ... I believe like 7 in LA, for example, one of the VA's there hosts like a safe parking in their parking lot part to 8 serve the veterans that often their patients, and so, we could think of other institutions that 9 could be hosts to these types of programs, besides congregations and perhaps could have 10 larger capacity for RVs. So, it would be both allowing other types of parking lots to host Safe 11 Parking and including RVs in who they could serve, but then the other challenge, or thing to do, 12 would be to find the service provider to match with those lots to then service the RV 13 community. And again, whether or not those are twenty-four hours lots where they can stay 14 kind of you know and not have to move frequently, or if it's a similar to the congregation 15 program. So, not an unsolvable problem, but certainly would take some different dimensions 16 possibly than the program that we're considering today.

So, I will say, Melissa, I don't know if you know this chart that 2 we're looking at doesn't differentiate cars from RVs, so I'm not sure if that number includes RVs 3 or not, but the point is, we have more people who are living in their vehicles than we have Safe 4 Parking spots, I think still stands, just how far from that number, it kind of depends on what 5 we're counting. The only thing I would say, and not to prolong this joint hearing, but certainly if 6 there are any Commissioners from the HRC who had any thoughts regarding preferences, 7 density, other things that the PTC were voting on, I think they would appreciate to hear that 8 now, as opposed to after they voted. And then if not, the PTC would adjourn, under the Chair, 9 I'm satisfied as a staff person with the hearing.

1 cars. So, I think giving some freedom to match mission with program is critical. The other thing 2 that I've heard from several faith leaders is that the Palo Alto process has been applied to this 3 and as a faith leader, you want to do good, but you also don't want to be stretched out, so as 4 we consider the appeal process, understanding that churches/faith institutions doesn't want 5 negative press, don't want to be dragged, you know, there was at the initial time of the 6 program, there was fear mongering... like are we getting drug addicts, are we getting people 7 that are criminals, are we getting this, and so, we will need the spaces, but how we do the 8 appeal process I think needs to be adjusted, understanding some of the sensitivities in the 9 institutions. And finally, I think we should look beyond faith institutions, to expand because they're... we are going to tap out in capacity, particularly if we... I agree with the 1200 feet on 10 11 Middlefield, or church corridor, so when you start doing that, you take out the churches on 12 Middlefield, but you also take out the churches behind them, like the Christ of Christian 13 Scientists, and part of the catholic church property. And a lot of those other properties they 14 don't count for some other streets. So, we should look at incorporating other community 15 partners in this process, because I think there will be a need, and I think it is a good thing. And a 16 final thing, the Chair, she made a.... I think an astute observation that maybe we should look at 17 scaling the amount of people or cars. We can have more property based on some quotient for... 18 and I'm just.... A random number for every 25 spaces RV, or twenty spaces, you can get one 19 extra car, or some number that. And I don't know the match, don't quote me on twenty, 20 because I don't know church parking lots. I know what a church parking lot is, but I think it

1 there might be an advantage to be gained from particularly the operators point of view, into 2 having more closely spaced sites. So, I'm still struggling with that if we can, in our discussion 3 think about that a little bit more, it might come to clarity on that for me. And the last 4 observation is I suspect we should recommend that there is some path for having more spaces 5 per site. I don't know exactly what that path should be, but as the outreach process really takes 6 off, then perhaps we'll get a little more contention for these spaces. I'm a little uncertain about 7 that because we don't seem to be getting families in the congregation spaces, and that perhaps 8 is directly related to the lack of RV support and those spaces. So, it gets complicated quickly, 9 but I think I would feel more comfortable if there were a path for congregations to offer more. 10 That's everything that's on my list. Thank you.

<u>Vice Chair Chang</u>: I think Commissioner Akin highlighted the three kind of decision points for me too, everything else that's in the Ordinance, I support. So, regarding the density, I think how I feel about the density can be traded off with the question about finding a way for congregations to host more than four participants, vehicles. And the reason I say that is because on the one hand, initially, I was thinking that I... that density kind of wasn't an issue. Because as the ... if we think about all the churches on Middlefield, which is probably where it's most likely going to be impacted as well as sort of the blocks parallel to Middlefield. The

1 institutions on Middlefield are quite large for the most part, with very large parking lots, and so 2 they are spaced very far apart as it is. It doesn't seem like there would be a huge impact there. It would be a different situation if there was a church corridor in downtown Palo Alto. But, if we 3 4 were then to say... have some sort of ratio, either square feet of parking lot space or number of 5 parking spaces and then allow many institutions on Middlefield to host many more than four 6 vehicles, then I think there could start to be some pushback from the community. So, where I 7 stand on this.... I don't... I think that would need to be studied a little bit more, because I'm not 8 sure that we know what the right number would be unless it's a very small tweak, like an 9 additional two vehicles, or something like that. But if it were a blanket kind of per parking spot or per square footage rule, I don't know what the implications of that would be, and that would 10 11 make me feel a little more nervous. And, I wouldn't want to touch that unless we also put a 12 density... you know something like 1200 feet requirement. And I don't think the preferences are 13 necessary at this point in time. 2 Commissioner Hechtman: Okay. So, I used to represent what are called small scaled group 3 recovery homes. And these are facilities for six or fewer people in recovery. Drug or alcohol 4 addiction typically, and once upon a time, you had to get a local permit to occupy a house for 5 that purpose in a residential neighborhood. And, there was a tremendous amount of fear 6 expressed by the neighbors. Ultimately, the Federal Government came in and said six or fewer, 7 it's federal rules, no local permit. But what happened over time, was largely those facilities 8 moved in and did not cause a problem in the neighborhood. You know, because these are... the 9 clientele there are people who are wanting to get better. There are exceptions to every rule, 10 but when I think about that experience, it reminds me of the fear that can be felt by neighbors 11 in close proximity to homeless sheltering; and you know I really took to heart Chair Smith's 12 comments about sort of the challenges that congregations face, faith based, in wanting to do 13 this but not wanting to alienate their neighbors. And so, I think as we move forward, we want 14 to encourage more congregations to do this and we have to help them by not creating a 15 scenario that unnecessarily creates more fear in the neighborhood. So, when I think about the maximum of four, and I hear some of my fellow Commissioners, I do think that there should be 16 17 a path to more than four, and I was thinking of something like, you know, every year you can 18 add two, up to a maximum of eight, or whatever maximum it is, but that way you have to start 19 with four and let it operate, let the neighborhood realize that it's not a problem, and then a 20 small bump up, if there's demand and the congregation wants to do it, and then maybe one

1 more a year later after that. So, that's one concept that maybe could thread this needle 2 without having to come back and amend the ordinance later. The ordinance does incidentally, 3 in its findings, it does talk about four. So we'd have to look at that if we want to implement 4 something like that. In terms of the density issue, you know, one thing that occurred to me... 5 because I hadn't really thought about this geographically, and honestly, I don't think I have 6 enough information to recommend supporting 1200 or any number, but I do think that we can 7 help the Council look at this if, when this goes to Council, staff will prepare a map with all of the 8 faith based institutions and a 1200 foot diameter, radiating from each one of them so we can 9 start to see, right, how many... how much we're excluding if we do something like that. And so, I would like them to ... if it's the consensus of the Commission, I would like the Council to know 10 11 that we're interested... we were interested enough in that possibility to have this data provided 12 to them for them to consider, without making a recommendation of let's do 1200 or not. So, 13 those are my thoughts on how to you know, adjust this ordinance as we recommend it to the 14 Council.

1 disruptive to be kicked out, while you're parents try and figure out how to secure new housing. 2 And it's disruptive not only you know, to their sense of stability, to their relationships, to their 3 schooling, but it's very financially valuable to be able to remail in this district. And so, I just feel 4 compassion, this has happened to several friends of mine, that have lost their houses, while 5 their kids are in district and they have had difficulty securing another one before the lease runs 6 out, because they get bumped, or the landlord raises the rent in the middle of negotiations so 7 sometimes it takes longer than you think, and they do need a temporary place to be able to 8 reside, or reside so that they can qualify to remain in the district. So, I do accept that we 9 currently are not at capacity, and this isn't an issue, but if you look ahead, a lot of financial gurus are telling us that we're not out of the woods yet in terms of the economy so, when you 10 11 think about this and plan ahead, make sure that those children are protected. So that's my plea 12 for that, thank you.

13

<u>Chair Summa</u>: I'm not seeing other lights. I would say that I agree with my Colleagues and I certainly think of the preferences, the one that really stands out is school kids, so I wouldn't mind leaving that one in there, and I think it's kind of the practice anyway of people that work with these communities, but I think it doesn't hurt to spell it out. So I would be fine with that and leaving the others out for now. I don't think they're as compelling. And then, I ... I myself personally, am not really concerned about the density issue, but given that others are, I would be perfectly happy to accept sort of a program as outlined by Commissioner Hechtman. That

sounds like a good compromise. And I really do like the idea of a map with churches. I would really want to see, and I think we could come to a conclusion about that if we had thought about it in that way before, but I would like to see 600 versus 1200, because 600 is the kind of accepted sphere of impact by project, that we currently accept. So that would be interesting for me to see. And, I think that covers the issues for me.

6

7 Commissioner Hechtman: If I could just drill down on the families with enrolled students 8 concept, again, recognizing that this ordinance doesn't apply to properties with RVs, right, this 9 is only the places where people are in cars where I think we hard from our representative of... 10 Mr. Love, thank you, that you're generally not having children, right, these are I don't know, 11 he didn't say always, but nearly always a single occupant in a car. And so, it's not a child. And 12 so, I'm just trying to think about whether this could actually... I mean, how does that work? If 13 you know, my congregation has this obligation to provide a preference to families with 14 students, first of all I think they would normally do that without being told. I think protecting 15 and helping children is the mission of every faith based organization. So, but I'm wondering if there could be a situation here where something that we don't want to happen, happens. And I 16 17 don't know what that would be. But anyway, that's my concern and I'm just voicing it, I don't 18 generally have a problem with keeping that, but I'm wondering if there's a risk that we're not 19 thinking of.

1 Commissioner Templeton: I'll just remind you that students can be homeless, and students can 2 be eighteen, so these are... not mutually exclusive scenarios, and often in the case of I 3 mentioned, which does happen frequently, if you're following any of these Palo Alto parents 4 groups, like multiple times a month, we're seeing people displaced from their home. They don't 5 have the RV, yet. They're trying to find a house, or an apartment or a place to rent. So, those 6 are people that would be in their cars as well. And even if they have a friend that their child can 7 stay with, they still need the residency in order to stay in the district. And if the organizations 8 are likely to comply anyway, they shouldn't object to this restriction.

9

10 <u>Chair Summa</u>: Commissioner Akin and then Commissioner Lu.

12 <u>Commissioner Akin</u>: Yeah, just a brief observation about a map with twelve... with six hundred 13 foot radius from faith based institutions, you don't want to create something that... where the 14 coverage is so high that it looks intimidating. We may ... we may have a relatively small number 15 of congregations who are interested in doing this and we would never run across any overlap, 16 but if you provide a diagram of that sort, you may find that huge areas have overlap of one kind 17 or another. And, I wouldn't want that to dissuade Council from considering liberalization of the 18 rules we're proposing here.

2 Commissioner Lu: Thank you. A few thoughts... just recapping some of the really comments so 3 far, on density, I have significant reservations about density restrictions. I think there's inherent 4 value in having as many congregations as would like to participate, participate. And a broader, 5 just network of people and institutions that can support people who participate in this 6 program. On capacity, I think Commissioner Hechtman's plan sounds totally reasonable to me. 7 On preferences, I generally support preference 1, I think there's also value in preference 2. The 8 preference for people who have lived in the community or are involved in local community, this 9 is maybe an abstract concern now while there's still plenty of capacity, but I think it's likely that 10 could just be better outcomes for people net net across the entire system if people can have 11 safe parking near their families, near communities that they've engaged in. So, preference 2 12 could also maximize the amount of good that our program can do. To throw one wrinkle here, 13 when talking about families and how many participants are single people in a single passenger 14 vehicle, we do have the option of accepting RVs, and there could be some trade off like you 15 could have four passenger vehicles, or two RVs, or some fractional combination there of; I can't think of reason why RVs are inherently worse in any way, like they're inherently louder, 16 17 inherently ... more likely to lead to public safety incidents or anything like that. Maybe the only 18 possible thing is that RVs are slightly taller and slightly more visible, but this feels like relatively 19 moderate in the context of mostly large parking lots. So, yeah, I'd like that they would offer it for peoples consideration as well. 20

4 Vice Chair Chang: So, as I'm listening to all the really good comments, I want to remind us all 5 that the operator said that there's no barrier to implementing these preferences, but then from 6 a legislative perspective, there's no point in putting rules in if they're unnecessary. It just makes 7 for messy code. But I do also concur with Commissioner Templeton that the impact on 8 students is going to be much larger than the impact on any other group that might be given 9 preferences, and so even thought it's not an issue right now, and even thought this operator would likely prioritize families with children in PAUSD anyway, it's probably worthwhile because 10 11 it's such an important point, with such an outsized impact on the lives of the program 12 participants, if they are enrolled in school here. I think Commissioner Lu brings up a really good 13 point, and I wonder if it would be worth while to build in the flexibility to allow us to 14 accommodate RVs, that said, I would defer to the operator, so there's a reason that the 15 operator doesn't ... it is difficult possibly because it's also not very attractive as Ms. Tanner 16 mentioned, for RV owners to have to move their very large vehicle, and find someplace else to 17 put their very large vehicle, every day. But, that being said, if we want to think forward, there 18 may be a reason to build in some flexibility, especially because there are some very large 19 parking lots at some of the faith institutions, that could easily accommodate RVs. So, that's just 20 a thought. I kind of like that idea, that this is ordinance. We know how slow this process is, so

by the time there's a need, I mean this pilot was put in pre-pandemic and now we're finally making it permanent. So, by the time there's a need, it may be too late, so I wonder if we wouldn't want to maybe make that a possibility; and make it one where the congregation, as well as the, you know, the operator can always choose to utilize that space or not, but kind of leave it up to the congregation. I mean we could put parameters around it such as two for one, or something like that. Thanks.

10 <u>Commissioner Templeton</u>: Thank you. I also wanted to respond about whether or not RVs 11 present more of a health hazard than cars. It's my understanding that yes, they do, because of 12 the dumping of waste matter. Yeah, I'm talking about sewage. So, I was wondering if staff 13 wanted to respond to that and maybe it would help us move on past this issue. Thank you.

I would say certainly the issue of discarding waste water is present in RVs and not present in a typical vehicle, I think there is... if that's not properly attended to, then that can become a problem and unfortunately has in some communities in the recent past, relative to RV's waste water. I would say, just in terms of vehicle limit overall, you know if the Commission did want to give staff direction to you know, develop a clause that Council could incorporate around allowing... whether it's up to eight

1 vehicles max, again RVs are allowed, I think just programmatically not currently happening right 2 now, because of the program operators preferences and kind of the way that they have a feel 3 it's best to serve folks who are living in RVs, so there could be a different operator that a church 4 works with that does want to place RVs there. I will also say, related to just the challenges at 5 some congregations have overcome with neighbors that was often a discussion point, well what 6 kind of vehicles are going to be there and having kind of regular cars, if you will, was more 7 palatable than maybe having RVs. So, just to say, RVs are allowed under the current ordinance, 8 I mean certainly if you want to create a max, it doesn't mean the congregation has to serve 9 that, so if Move Mountainview and the congregation felt four was fine, they wouldn't need to 10 go up to eight, but they could have the flexibility under the ordinance to do so, that might be 11 something that ... especially if they're also proximity limitations then we can still serve more 12 people but it just may not be at more congregations.

Okay, again, good evening, I'm Dan Wery from Michael 2 Baker International, Surabhi and I are here, we're kind of the lead on your team here, we've 3 been working with staff for quite a while, and what we wanted to do was just kind of present 4 and introduce the Retail Recovery study. We started a while ago and we can give you a little bit of update, but we've got some preliminary work that we've done so far, but we just wanted to 5 6 introduce you overall, to the project. The goal of the study is to retain, strengthen and facilitate 7 retail in the key commercial areas of Palo Alto. Really trying to retain and recover the thriving 8 retail activity. And you know, one key component to this is to modernize the regulations and 9 ensure a vibrant commercial area. So just real quick, we'll jump on and look at the study area, so these are all kind of the primary commercial areas, in Palo Alto, our focus is really on four 10 11 key areas, centered on University Avenue, California Avenue, Midtown shopping center, and 12 the retail components or zones on El Camino Real. Primarily on the east and west of the 13 intersection with California Avenue. Those are the CN and CS zones. And then just kind of what 14 we're... what's in the study that we're doing and what are the main components, so we're 15 looking at best practice research, we looked around and we're benchmarking all good practices 16 relating to retail recovery and good retail practices in general, we've studied the retail trends 17 and analysis, they've been evolving as you know, quite a bit. Peer city interviews and research, 18 we started off with a couple, we just finished with a third peer city review. So, again, looking at 19 our best practices and more locally how those local examples that may apply more specifically 20 to Palo Alto. And then stakeholder interviews as well. We're shooting for about twelve, we've

1 got about seven so far and we're looking for some more. And then we're doing a constraints 2 analysis on your zoning and procedures, a deep dive. And then other components include, and 3 these are some of the newer things that we've added on more recently, is the look at the 4 impacts of AB2097, which eliminates minimum parking requirements within a half mile of high 5 frequency transit, particularly train stations. So that covers virtually all of University and 6 California districts. And then incorporating the Streetsense Economic Development Strategy 7 report that was just concluded and completed, so, we've seen a lot of... what we saw in our 8 preliminary analysis was really heavily documented and explained in the Streetsense report so 9 that's very nice to see there's a lot of synergy between those and we'll be incorporating that 10 into our final report. And then ultimately the goal is to make recommended land use changes, 11 land use zoning controls, regulatory changes. We are also... have been asked to look at the 12 parking, again because of AB 2097 in particular, but also because parking in general is often a 13 critical component to all the other retail components. And then we have scope and budget for a 14 number of meetings with the PTC and then also two meetings with the City Council. And then 15 ultimately when we work through that we'll have a final report. So we do expect to be back with you as we make further progress, and have more detailed findings, but we're going to kind 16 17 of just give you an overview tonight. And then I think Surabhi was going to kind of cover in a 18 little bit more detail the outreach.

We have documented the interviews and you'll see the memo of the findings of 5 these interviews. Along with that, we have also done interviews with local cities, including 6 Redwood City and Mountainview City in the first round of research. We recently interviewed 7 the peer city of Santa Monica, and we will be doing research up there based on this interview as 8 well as the interviews in the memo and submitting it to the City. Next slide please.

12 Ms. Barbhaya, Consultant: So this is a tentative schedule for this project, we had our first 13 meeting with staff in July, and we are in the process of doing stakeholder interviews, we've 14 done a few. We hope to wrap up the stakeholder interviews by the end of November, if 15 possible. We have wrapped up the interviews with the peer cities and neighboring cities and we will submit a memo hopefully by October end, or mid November. The best practices 16 17 documented back in the first round, we will revise that and resubmit it to the City by the end of 18 November, and we will start... we just started parking analysis with collecting data and trying to 19 figure out what data is available from the city. And then we'll do the parking study analysis 20 based on the data available. As far as zoning review and recommendations we hope to have

So the study is focused on what that threshold would be, at what time the city needs to implement a parking strategy or TDM strategy.

8 <u>Commissioner Akin</u>: Thank you, I just wondered if you were aware of this history of already 9 using adjacent areas as parking resources. So, if you do a census strictly on the basis of garage 10 space and on street parking in the downtown commercial district, that won't be an accurate 11 reflection of how parking resources in the are used. Particularly as AB 2097 comes into play, 12 there would, I presume, there would be additional pressure to use parking resources other than 13 those two types that you've identified. Other than the garages and the on street parking in the 14 commercial district. So I think that really needs to be a part of your analysis. I can't offer you 15 advice on what the correct way to do that is, but it is an issue that you should keep in mind.

So, again, looking at your scope of work, there's 13 references to parking, but no references to biking or walking. I did see in one of Dan's slide, that 14 part of your process is going to be to integrate the Streetsense report which does highlight the 15 importance of these things, but maybe you could ... but I did want to clarify that this access by means other than vehicle is... will be a part of your study, or tell me it won't be. 16

Mr. Wery, Consultant: Yeah, it wasn't specifically looking at that but it is one of the overall kind of trends and best practices, is making sure that there's a strong emphasis on all modes of activities, not just cars. Obviously parking is a big part of it to get people in, but again, these are

1 in many ways serving the immediate neighborhoods as well, so that pedestrian access and bring 2 in bike activity from broader areas, will certainly be a critical function. So, we will look at the 3 facilities, and things like how it's accommodated, in terms of the physical kind of streetscape 4 but that... our focus has been primarily on looking at the zoning and procedures and what are 5 the best practices. 1 whole purple area to count the parking in. So I wanted to let you know that and, we did get a 2 number of... Commissioner Hechtman already mentioned it, letters about bike and ped and 3 also ADA, one of the letters emphasized ADA considerations, so I think that would be very 4 important to include in here. And I wanted to ask, in the report that Council considered in 5 August, accepted, there is ... I believe a list from Streetsense of their stakeholder interviewees, 6 and I'm hoping that your interviews will include more small businesses and as Commissioner Lu 7 mentioned, landlords also. This list doesn't really capture what I would think would be as 8 helpful as talking to more business owners that operate in all of our business districts. That's all 9 for me for now, Commissioner Akin.

There were several others I think we looked at, but 9 we had really good interviews that were very helpful and still the trends and their practices 10 were consistent to what we were thinking; and then we just added Santa Monica because that 11 was identified as more of comparable, directly comparable example. So, if staff wants to look 12 at others, we can talk about doing Sunnyvale or Cupertino or Los Altos, or even Pasadena.

The other thing that we 18 have also been looking at was looking at the actual occupancy rates and trying to track those 19 over time with a variety of different sources. And try to see how those trends, and try to 20 corelate that with the regulations, and then also I don't think we can necessarily quantify and

1 say if you make this change in your standard or regulation you're going to have this economic 2 result, that's why that phrasing was kind of confusing. But, we are looking at where, for 3 example, peer cities and other best practices ... what results they've had after they've made 4 changes. So that's probably what that's referring to. Is you know, if we're able to quantify and 5 say after making certain certain technical changes or procedural changes, whether they are 6 temporary or permanent, if they can show, he we've generated a number of... attracted new 7 business, we've retained uses, we've increased foot traffic, perhaps increased sales, so where 8 that data is available, we're trying to pull that in. I believe the Streetsense study actually has 9 some really good information that we're hoping to pull in along that line.
