The Basic Citizens Police Academy is an 8-week course designed to foster increased understanding and communication between community members and the police. The Citizens Police Academy

gives participants detailed insight into how our Department operates and how we serve the community. It creates well-informed community members who possess greater insight into police practices and services. Everyone, including the police, benefits from increased communication and mutual understanding.

The Citizens Police Academy is not designed to train the participant as a police officer; it is solely for education purposes only. Applications are accepted on a continuous basis, and there is no cost for the program other than your time. Each academy class is limited to 25 participants. Preference is given to Palo Alto residents, community members who work in Palo Alto, and people employed by the City of Palo Alto.

### **Minimum Qualifications:**

- > At least 14 years of age (minors require parent/guardian consent)
- Live or work in Palo Alto, or the immediate surrounding community
- No felony convictions; no misdemeanor convictions within one year
- > The ability to successfully pass a criminal background check.

### **Application Process:**

- 1. Written application (this document)
- 2. Interview with Citizens Police Academy coordinator (parent/guardian must accompany applicants who are under 18 years of age)
- 3. Criminal background check
