

# **New Restroom Facility**





# Why a new restroom?

- Requested by field users for many years
- Currently portable restrooms being used on site
- Provide better facilities for the community
- Space is available adjacent to the field
- Is a much needed amenity to the heavily used field





# Does the new restroom impact the Cubberley Master Plan?

- Per initial meetings concerning the master plan no suggestions to move the field have been made
- A pre-fabricated restroom provides the opportunity to relocate it the future if necessary
- A restroom facility is need now





# **Restroom Facility**

- Install pre-fabricated restroom building (built-off site & craned into position)
- Requires a new sewer line trenched to Nelson Drive (path to remain open)
- Path between the parking lot and Nelson Drive to be repaved
- Water & power existing at proposed location
- Site selected for access and visibility to all adjacent fields






### **Restroom Features**

- Two ADA stalls (unisex)
- Easily accessible service area
- Time locks during no field use hours
- Ample stall ventilation
- Epoxy coated concrete floors
- Easily cleaned interiors
- Concrete pad walkway
- Graffiti resistant exterior
- Exterior low voltage lighting fixtures
- Clear restroom rule signage
- Easy service maintenance space




# **Synthetic Turf Replacement**





# Why replacement is needed?


- Field expected use period from 8-10 years (Installed in 2010)
- Areas over compacted
- Field sub-surface requires fine grading
- Cubberley is one of the heaviest programmed fields in the city





# Does the field replacement impact the Cubberley Master Plan?


- Per initial meetings concerning the master plan no suggestions to move the field have been made
- The fields life span would allow for future modifications if required by the master plan
- The field is need of replacement now
- Capital improvement funding has already been set aside for the replacement (\$1.9M)





### **Synthetic Field**

- Regrade entire area for level surface
- Replace turf with city approved turf type used at Stanford and El Camino play fields
- Utilize city approved in fill TPE material used at Stanford and El Camino play fields (non toxic)
- City to work with field users on striping needs






# Rubber Track Bid Alternate
