# b. Philip Dah, Senior Director, LifeMoves Opportunity Services Center & Hotel de Zink Shelter

Mr. Dah explained that through LifeMoves' Opportunity Center they provide rental assistance and are part of the EAN, Emergency Assistance Network of Santa Clara County. They provide rent assistance and eviction intervention for folks who live in Palo Alto among several other services.

# c. Leah Cowan, local renter

Ms. Cowan is a longtime resident and renter in Palo Alto. She shared her family experience living in a BMR Section 8 unit.

# d. Angie Evans, local housing justice advocate

Ms. Evans provided information about the newly formed Palo Alto Renters' Association which is governed by an eight-person steering committee which priorities include a rent registry, public education, tenant harassment and affordable housing.
